SPRINGER, PROFESSIONAL LAND SURVEYOR, REGISTERED IN THE STATE OF OREGON, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS, THE PARCELS OF THIS LAND PARTITION. SAID LAND PARTITION BEING SITUATED IN THE NW1/4 SECTION 1, T.9S., R.27E., W.M., CITY OF MONUMENT, GRANT COUNTY, OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE INITIAL POINT WHICH IS A 5/8" IRON PIN WITH ATTACHED YELLOW PLASTIC CAP MARKED BGB SURVEY MARKER, SAID POINT BEING 1506.53 FEET NORTH AND 1763.29 FEET WEST FROM MONUMENTED C1/4 CORNER, SAID SECTION 1;

THENCE S.02°53'27"W., 339.07 FEET TO A POINT ON THE NORTHERLY RIGHT OF WAY LINE OF THE RELOCATED KIMBERLY-MONUMENT HIGHWAY;

THENCE ALONG SAID HIGHWAY RIGHT OF WAY LINE, 313.38 FEET ALONG A 40 FOOT OFFSET SPIRAL CURVE LEFT, THE LONG CHORD OF WHICH BEARS N.52*29'06"W., 313.19 FEET TO HIGHWAY STATION 710+15.59 PSC;

THENCE 265.15 FEET ALONG THE ARC OF A 1949.86 FOOT RADIUS CURVE LEFT (THE LONG CHORD OF WHICH BEARS N.60°12'50"W., 264.95 FEET) TO HIGHWAY STATION 707+55.00 POC, 40 FEET LEFT;

THENCE CONTINUING ALONG SAID RIGHT OF WAY LINE N.25°53'26"E., 60.00 FEET TO HIGHWAY STATION 707+55.00 POC, 100 FEET LEFT, SAID POINT ALSO BEING ON THE SOUTHERLY RIGHT OF WAY LINE OF THE OLD KIMBERLY-MONUMENT HIGHWAY;

THENCE, LEAVING SAID RELOCATED KIMBERLY-MONUMENT HIGHWAY RIGHT OF WAY LINE, S.85°18'34"E., 253.52 FEET ALONG THE SOUTHERLY RIGHT OF WAY LINE OF THE OLD KIMBERLY-MONUMENT HIGHWAY;



RECORDED DECEMBER 30, 1946 IN BOOK 49, PAGE 281. SAID EASEMENT IS SHOWN HEREON AT THE RELOCATED KIMBERLY—LONG CREEK HIGHWAY, WIDTH VARIES.
- 4. PUBLIC EASEMENT, INCLUDING THE TERMS AND PROVISIONS THEREOF, FOR WASTE WATER COLLECTION AND PUMPING STATION; RECORDED AUGUST 23, 1999 IN DEED INSTRUMENT NO. 992451. SAID EASEMENT BEING 10 FEET IN WIDTH. THIS EASEMENT IS LOCATED SOUTHERLY AND ADJACENT TO THE SOUTHWEST RIGHT OF WAY LINE OF THE RELOCATED KIMBERLY—MONUMENT HIGHWAY AND IS NOT APPURTENANT TO THE SUBJECT PROPERTY.

NARRATIVE

THIS LAND PARTITION PLAT WAS PREPARED AT THE REQUEST OF JERRY BOYER, OWNER THE LAND DESCRIBED IN DEED INSTRUMENT NO'S 202009 AND 20071738. THE PURPOSE OF THIS PROJECT WAS TO PARTITION MR. BOYER'S PROPERTY INTO TWO PARCELS AS SHOWN ON THE ANNEXED PLAT.

A SEARCH WAS MADE OF AVAILABLE RECORDS PERTAINING TO THIS SURVEY AND FIELD MEASUREMENTS WERE MADE TO LOCATE APPURTENANT CONTROLLING MONUMENTS FROM RECORD SURVEY NO.'S 863 AND 1452 AND LAND PARTITION PLAT NO.'S 98-24, 2001-14, 2007-26 AND 2009-10. I ALSO UTILIZED THE CENTERLINE ALIGNMENT AND RIGHT OF WAY WIDTHS FROM OREGON STATE HIGHWAY DEPARTMENT MAP NO. 6B-20-5. UNLESS OTHERWISE NOTED, I ACCEPT THE FOUND MONUMENTS SHOWN HEREON.

IN ORDER TO DETERMINE THE RIGHT OF WAY LINES OF THE RELOCATED KIMBERLY—MONUMENT HIGHWAY, I HELD THE IRON PINS ALONG THE SOUTH RIGHT OF WAY LINE FROM LAND PARTITION PLAT NO. 98–24 AND THE PIN ON NORTH RIGHT OF WAY LINE FROM LAND PARTITION PLAT NO. 2007–26. THESE FOUND PINS FIT HARMONIOUSLY WITH THE ALIGNMENT DEPICTED ON HIGHWAY MAP NO. 6B–20–5.

I HELD THE FOUND PINS SHOWN HEREON AND THE RECORD ALIGNMENT FROM PREVIOUS SURVEYS TO DETERMINE THE CENTERLINE AND RIGHT OF WAY LINES OLD KIMBERLY—MONUMENT HIGHWAY. HIGHWAY MAP NO 6B—20—5 SHOWS THE NORTHERLY RIGHT OF WAY LINE OF THE RELOCATED HIGHWAY WIDENING TO A WIDTH OF 100 FEET AT STATION 707+55 TO CREATE AN INTERSECTION FROM THE OLD HIGHWAY TO THE RELOCATED HIGHWAY. IN ORDER TO AVOID A GAP BETWEEN THE TWO RIGHT OF WAYS, I DROVE A LINE FROM THE END OF RIGHT OF WAY CURVE 3 (C3) TO HIGHWAY STATION 707+55, 100 FT. LEFT. THE RESULTANT LINE HONORS THE EXISTING RECORD AND ACCEPTED PINS AND THE CENTERLINE ALIGNMENTS WHILE AT THE SAME TIME AVOIDING AN UNINTENDED GAP BETWEEN THE RIGHT OF WAY LINES.

I SET NEW PINS ACCORDING TO THE EVIDENCE FOUND, AND AT LOCATIONS APPROVED BY MR. BOYER AND AS OUTLINED HEREIN. GOD BLESS AMERICA.


