


SURVEYOR'S CERTIFICATE

STATE OF OREGON COUNTY OF GRANT SS:

I, Robert D. Bagett, being first duly sworn, hereby depose and say that I have shown the unsurveyed partitions and exception on this partition plat, described as follows:

Beginning at the southeast corner of section 13, Twp. 12 S., R.28 E., W.M., Grant County, Oregon;

thence West, along the south line of sections 13 and 14, a distance of 9240 feet, more or less, to the southwest corner of the E1/2SW1/4 of said section 14;

thence North, along the west line of the E1/2SW1/4 and the SE1/4NW1/4 of section 14, a distance of 3960 ft., more or less, to the southeast corner of the NW1/4NW1/4 of said section 14;

thence West, along the south line of the NW1/4NW1/4 of said section 14, a distance of 1320 feet, more or less, to the southwest corner of said NW1/4NW1/4;

thence North, along the west line of the NW1/4NW1/4 of said section 14, a distance of 1320 feet, more or less, to the Northwest corner of the NW1/4NW1/4 of said section 14;

thence East, along the North line of sections 14 and 13, a distance of 7920 feet, more or less, to the northeast corner of the NW1/4 of said section 13;

thence South, along the East line of the NW1/4 of said section 13, a distance of 2640 feet, more of less, to the northwest corner of the SE1/4 of said section 13;
