

I INTERSECTED THE WESTERLY MONUMENTED RIGHT OF WAY LINE OF COUNTY

ROAD NO. 74-G, AS ESTABLISHED IN SURVEY NO. 1047, WITH THE DIVISION

LINE BETWEEN PARCEL 1 AND 2, AS SHOWN. I INTERSECTED THE EASTERLY

MONUMENTED RIGHT OF WAY LINE OF COUNTY ROAD NO. 74-H, AS ESTABLISHED

IN SAID SURVEY NO. 1047, WITH THE DIVISION LINE BETWEEN PARCEL 1

AND 2, AS SHOWN. I INTERSECTED THE EASTERLY RIGHT OF WAY LINE OF

COUNTY ROAD NO. 74-H WITH THE NORTH LINE OF THE NW1/4SE1/4 AND SET A

THE TITLE TO THIS TRACT IS DESCRIBED AS LYING NORTH AND WEST OF THE

CENTERLINE OF ROAD EASEMENT "G" AND EAST OF THE CENTERLINE OF ROAD EASEMENT "H", SUBJECT TO EASEMENT DEEDS TO GRANT COUNTY ALONG THESE

PIN THERE, AS SHOWN.

(1) THE NET AREA OF EACH PARCEL IS CALCULATED TO THE INSIDE EASEMENT LINES OF COUNTY ROADS 74-G AND 74-H, THE GROSS AREA OF EACH PARCEL IS CALCULATED TO THE CENTER LINE OF ROAD EASEMENTS "G" AND "H".
THE CENTERLINE OF ROAD EASEMENT "G" AND "H" COINCIDE WITH THE CENTERLINE OF COUNTY ROAD 74-G AND 74-H RESPECTIVELY. (2) I FIND NO RECORD OR EXISTENCE OF AN APPURTENANT GEODETIC CÓNTROL MONUMENT WITHIN 1/2 MILE OF THIS LAND PARTITION.

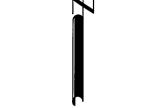
