NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF BOB CRAIG. THE PURPOSE OF THIS SURVEY WAS TO CREATE 2 PARCELS WITH THIS LAND PARTITION AND TO SET MONUMENTS ON THE DIVISION LINE BETWEEN PARCELS 1 AND 2 AS SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE THE CENTER 1/4 CORNER AND THE N1/4 CORNER OF SECTION 1, THE CUMMINGS DITCH, AND THE EXISTING ACCESS ROAD. NEW MONUMENTS WERE SET AT THE CORNERS OF PARCEL 2 AT POSITIONS APPROVED BY MR. CRAIG, AS SHOWN HEREON.

WE RETRACED THE WEST LINE OF THE NE1/4 OF SECTION 1, FINDING THE CENTER 1/4 CORNER IN GOOD SHAPE. WE SEARCHED FOR BUT DID NOT FIND THE NORTH 1/4 CORNER MONUMENT WHICH WAS SET BY DOUGLAS FERGUSON, PLS 848, IN RECORD SURVEY NO. 1050. WE FOUND HIS REFERENCE POINTS FOR THIS CORNER, BUT WE DISAGREED WITH THE POSITION THE SWING TIES FROM THEM YIELDED. I CALLED MR. FERGUSON AND EXPLAINED THE SITUATION. HE RETRACED THE NORTH LINE OF SECTION 1 AND RESET THE NORTH 1/4 CORNER AT SINGLE PROPORTIONATE MEASURE BETWEEN THE NON HEREON HE APPARENTLY HAD AN ERROR IN THE SWING TIES TO HIS TIED AND IS SHOWN HEREON. HE APPARENTLY HAD AN ERROR IN THE SWING TIES TO HIS ORIGINAL N1/4 CORNER MONUMENT. THE MONUMENT HE ORIGINALLY SET WAS APPARENTLY DESTROYED IN FARMING OPERATIONS. HE WILL BE FILING A MAP OF SURVEY TO REFLECT THE


