

SURVEYOR'S CERTIFICATE

I, ROBERT D. BAGETT, PROFESSIONAL LAND SURVEYOR, REGISTERED IN THE STATE OF OREGON, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND REPRESENTED AS SHOWN ON THIS PARTITION PLAT, SAID PARTITION BEING SITUATED IN THE SW1/4SW1/4 AND IN THE NW1/4SW1/4 OF SECTION 2, T.14S., R.31E., W.M., GRANT COUNTY, OREGON, DESCRIBED AS FOLLOWS:

BEGINNING AT A 5/8" X 30" IRON PIN, WHICH I DESIGNATE TO BE THE INITIAL POINT FOR THIS LAND PARTITION, SAID POINT BEING ON THE WEST LINE OF SAID SECTION 2 AND BEING N.00°04'15"W., 1662.99 FEET FROM THE SOUTHWEST CORNER OF SAID SECTION 2, THENCE S.00°04'15"E., ALONG THE WEST LINE OF SAID SECTION 2, 833.78 FEET TO A POINT ON THE NORTHERLY RIGHT OF WAY LINE OF THE OLD IZEE ROAD; THENCE ALONG SAID NORTHERLY RIGHT OF WAY LINE AS FOLLOWS: 19.00 FEET ALONG THE ARC OF A 268.73 FOOT RADIUS CURVE RIGHT, (THE LONG CHORD OF WHICH BEARS N.42'32'56"E., 18.99 FEET), TO A POINT ON THE NORTHERLY RIGHT OF WAY LINE OF RELOCATED COUNTY ROAD NO. 51; THENCE ALONG SAID RELOCATED RIGHT OF WAY LINE AS FOLLOWS: 187.98 FEET ALONG THE ARC OF A 465.13 FOOT RADIUS CURVE RIGHT, (THE LONG CHORD OF WHICH BEARS N.46'45'30"E., 186.70 FEET); N.58'20'10"E., 873.09 FEET; THENCE LEAVING SAID RIGHT OF WAY LINE, N.32'08'20"W., 379.27 FEET; THENCE S.82'46'46"W., 696.78 FEET TO THE POINT OF BEGINNING.

THIS SURVEY WAS PERFORMED AT THE REQUEST OF RON MONROE. THE PURPOSE OF THIS SURVEY WAS TO DELINEATE PARCEL 1 AND PARCEL 2 OF THIS LAND PARTITION, AS SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE EXISTING MONUMENTS. NEW MONUMENTS WERE SET IN ACCORDANCE WITH THE EVIDENCE FOUND AND AT LOCATIONS APPROVED BY MR. MONROE AT CORNERS OF THE DIVISION LINE BETWEEN PARCEL 1 AND PARCEL 2, AS SHOWN.

THIS SURVEY IS A RETRACEMENT OF SURVEY NO. 684 AND OF THE NORTH RIGHT OF WAY LINE OF COUNTY ROAD NO. 51. AS PER RECORD MAP OF SURVEY NO. 1243, WHICH SURVEYS ESTABLISHED THE EXTERIOR BOUNDARIES

DURING THIS CURRENT SURVEY WE RAN A CLOSED LOOP CONTROL TRAVERSE AND TIED THE CONTROLLING MONUMENTED CORNERS AS SHOWN HEREON. I ACCEPTED THE FOUND MONUMENTS SHOWN AND HELD THE RECORD BEARINGS AND DISTANCES AS MUCH AS POSSIBLE, AS INDICATED HEREON.

DECLARATION

KNOW ALL PEOPLE BY THESE PRESENTS THAT WE, RONALD K. MONROE AND REBECCA L. MONROE, AS TENANTS BY THE ENTIRETY, DO HEREBY DECLARE THAT WE ARE THE OWNERS OF THE LANDS DESCRIBED IN THE SURVEYOR'S CERTIFICATE AND THAT WE HAVE CAUSED SAID LANDS TO BE PARTITIONED INTO PARCELS IN ACCORDANCE WITH THE PROVISIONS OF ORS CHAPTER 92, AS SHOWN ON THE ANNEXED MAP.

SAID PARCELS SUBJECT TO THE FOLLOWING:

- (1) A. EASEMENTS, LIENS, ENCUMBRANCES, INTERESTS OR CLAIMS THEREOF
 - WHICH ARE NOT SHOWN BY THE PUBLIC RECORDS. ANY FACTS, RIGHTS, INTERESTS OR CLAIMS WHICH ARE NOT SHOWN BY THE PUBLIC RECORDS BUT WHICH COULD BE ASCERTAINED BY AN INSPECTION OF THE LAND OR BY MAKING INQUIRY OF PERSONS IN POSSESSION THEREOF.
- (2) A. UNPATENTED MINING CLAIMS.
 B. RESERVATIONS OR EXCEPTIONS IN PATENTS OR IN ACTS AUTHORIZING
 - WATER RIGHTS, CLAIMS OR TITLE TO WATER;

EASEMENTS, INCLUDING THE TERMS AND PROVISIONS THEREOF, TO M. F. STOCKWELL DATED APRIL 18, 1921, RECORDED JUNE 9, 1921 IN BOOK 34, PAGE 137, DEEDS, AFFECTING SUBJECT PROPERTY AND ADDITIONAL LANDS, TO-WIT: "FIRST: A PERPETUAL RIGHT TO CONSTRUCT, RECONSTRUCT, REPAIR, MAINTAIN AND USE AND OPERATE A DITCH, AND/OR FLUME FOR THE CARRIAGE OF WATER OVER AND ACROSS THE GRANTOR'S LAND WITHIN THE LIMITS OF A STRIP OF LAND (33) THIRTY—THREE FEET WIDE, THE CENTER LINE WHEREOF IS SO MUCH OF THAT LINE DESIGNATED ON THE MAP AND IN THE CERTIFICATE AS "MAIN DITCH AND POINTS THEREOF" AS CROSSES GRANTOR'S LAND.

WILLDEN, HIS WIFE, HAVE AT NO TIME HAD A VESTED INTEREST OF RECORD IN THE SUBJECT LAND: "RIGHT OF WAY EASEMENT TO CALIFORNIA—PACIFIC UTILITIES COMPANY, A CORP., DATED JULY 6, 1956, RECORDED JULY 9, 1956 IN BOOK 75, PAGE 34, DEEDS, FOR UTILITY AND INCIDENTAL PURPOSES." (NOT PLOTTED DUE TO INSUFFICIENT DATA IN THE DEED DESCRIPTION.)
- RIGHT OF WAY EASEMENT, INCLUDING THE TERMS AND PROVISIONS THEREOF, TO JACK MCKENNA DBA BLUE MT. T V CABLE CO., DATED JUNE 24, 1971, RECORDED JUNE 14, 1971 IN BOOK 106, PAGE 155, TO-WIT: "A TELEVISION CABLE LINE WHERE THE CALIFORNIA-PACIFIC UTILITIES OR PACIFIC NW BELL NOW HAVE EXISTING LINE, AND WHEREVER THEY MAY BUILD LINE IN THE FUTURE OVER LAND NOW OWNED BY THE UNDERSIGNED IN SEC. 2, T.14S., R.31E., W.M.". (NOT PLOTED DUE TO INSUFFICIENT DATA IN THE DEED DESCRIPTION.)
- RIGHT OF THE PUBLIC IN AND TO THE USE OF ANY PORTION OF THE ABOVE DESCRIBED PROPERTY LYING WITHIN THE RIGHT OF WAY OF THE OLD IZEE COUNTY ROAD.
- (8) RIGHT OF WAY DEED, COUNTY ROAD NO. 51, INCLUDING THE TERMS AND PROVISIONS THEREOF, TO GRANT COUNTY, OREGON, DATED MARCH 17, 1994, RECORDED MARCH 25, 1994, IN THE RECORDS OF GRANT COUNTY, OREGON, AS INSTRUMENT NO. 940564, FOR ROADWAY AND PURPOSES INCIDENTAL THERETO.
