RESERVATION, INCLUDING THE TERMS AND PROVISIONS THEREOF, IN DEED FROM THE UNITED STATES OF AMERICA, ACTING BY AND THROUGH THE SECRETARY OF HEALTH, EDUCATION, AND WELFARE, ACTING BY AND THROUGH THE REGIONAL DIRECTOR FOR REGION IX OF THE DEPARTMENT OF HEALTH, EDUCATION, AND WELFARE, UNDER AND PURSUANT TO THE POWERS AND AUTHORITY CONTAINED IN THE FEDERAL PROPERTY AND ADMINISTRATIVE SERVICES ACT OF 1949 (63 STAT. 377), AS AMENDED AND THE CIVIL RIGHTS ACT OF 1964 (78 STAT. 241), AND REGULATIONS PROMULGATED THEREUNDER, DATED MARCH 15, 1968, RECORDED MAY 10, 1968 IN DEED BOOK 99, PAGE 147, TO—WIT: "SUBJECT TO THE EXPRESS UNDERSTANDING THAT THE LAND DESCRIBED HEREIN SHALL NOT BE USED FOR MERCANTILE OR COMMERCIAL PURPOSES. RESERVING TO THE UNITED STATES OF AMERICA FOR USE BY THE U.S. FOREST SERVICE OR ITS SUCCESSOR IN FUNCTION AN EXCLUSIVE EASEMENT TO IMPROVE, USE, OPERATE, PATROL AND MAINTAIN THE EXISTING LOGAN VALLEY ROAD NO. 162.".

ANY EASEMENTS, RIGHTS OF WAY, AND RESERVATIONS, AS THE SAME MAY EXIST OR APPEAR OF RECORD; AND THAT SAID SCHOOL DISTRICT DOES HEREBY DEDICATE, DONATE AND CONVEY TO THE PUBLIC FOR PUBLIC USE FOREVER, FIRST STREET, THE ALLEY BETWEEN PARCELS 1 AND 3 AND THE ACCESS AND UTILITIES EASEMENT THROUGH PARCEL 2 OF THIS PARTITION.

THIS SURVEY WAS PERFORMED AT THE REQUEST OF GRANT ADMINISTRATIVE SCHOOL DISTRICT NO. 3. THE PURPOSE OF THIS SURVEY WAS TO CREATE 3 PARCELS FROM THE SCHOOL DISTRICT PROPERTY WITH THIS LAND PARTITION.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE EXISTING CONTROLLING MONUMENTS. WE RETRACED THE APPURTENANT PORTIONS OF SENECA TOWN PLAT AND RECORD SURVEY NO.'S 496 AND 779.

SENECA WAS SURVEYED AND PLATTED BY H.D. HAYLEY, P.E., IN MARCH 1930, RECORDED MARCH 30, 1930. RECORD SURVEY NO. 496 WAS SURVEYED BY CHARLES PALMER, PLS 1287, IN JANUARY 1978. RECORD SURVEY NO. 779 WAS SURVEYED BY ROBERT BAGETT, PLS 598, IN AUGUST. 1983.
