Lucas, Surveyor for Grant County, Oregon, being duly sworn depose and say that I made the survey of Subdivision as represented on this map, 1/16th inch included within boundaries as plotted is within the NE 1/4th of Section 26, T.13-S, R.31-E, M.M. That this map correctly represents the ground as surveyed and described as follows: Initial Point— The SW corner of the NE 1/4th of Section 26 T.13-S, R.31-E, M.M. - R.12"x.12" Concrete Post set at the above described 1/4 corner, as surveyed by a former County Surveyor, and since commonly recognized as being the said McCornor.

Commencing at the above described Initial Point Thence— North 1°37' West 337.0 feet to south boundary of Main Street, Thence South 87°30' East along South boundary of Main Street, Thence South 87°30' East along South boundary of Main Street, 655.2 feet, Thence South 0°48' East 321.0 feet, to East-West line, Thence North 88°58' West 650.2 feet to point of beginning

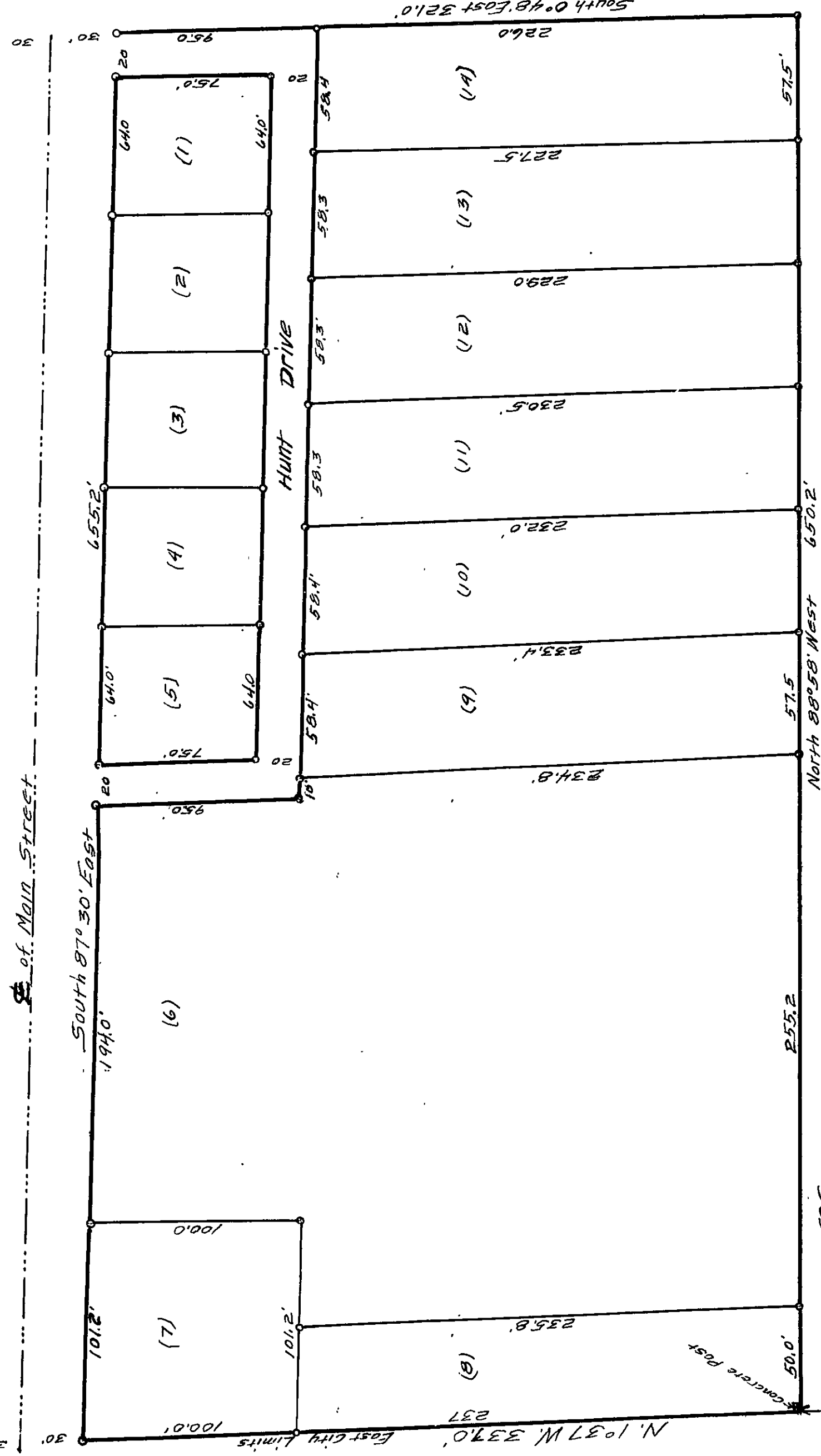
