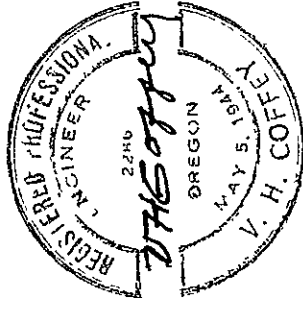


# BESWICK ADDITION

## CERTIFICATE

I, V. H. Coffey, first being duly sworn depose and say that I made the survey of Beswick Addition as represented on this map that the land included within boundaries as platted is in the SW 1/4 - SW 1/4 of Section 23 T. 13 S. R. 31 E. W. 4 M. That this map correctly represents the ground as surveyed and described as follows:

Beginning at the Initial Point a 3" Iron Pipe 3 ft in length, driven at the S.E. Corner of this tract which point is 804.07 ft. N. and 50.07 ft. W. of S.E. Cor. of SW 1/4 - SW 1/4 of Section 23 T. 13 S. R. 31 E. W. 4 M., thence West 200.0 ft.; South 20.0 ft.; West 280.0 ft.; South 93.0 ft.; West 70.0 ft.; N. 4° 50' W. 320.1 ft.; North 258.0 ft.; East 577.0 ft.; South 464.0 ft. to point of beginning.

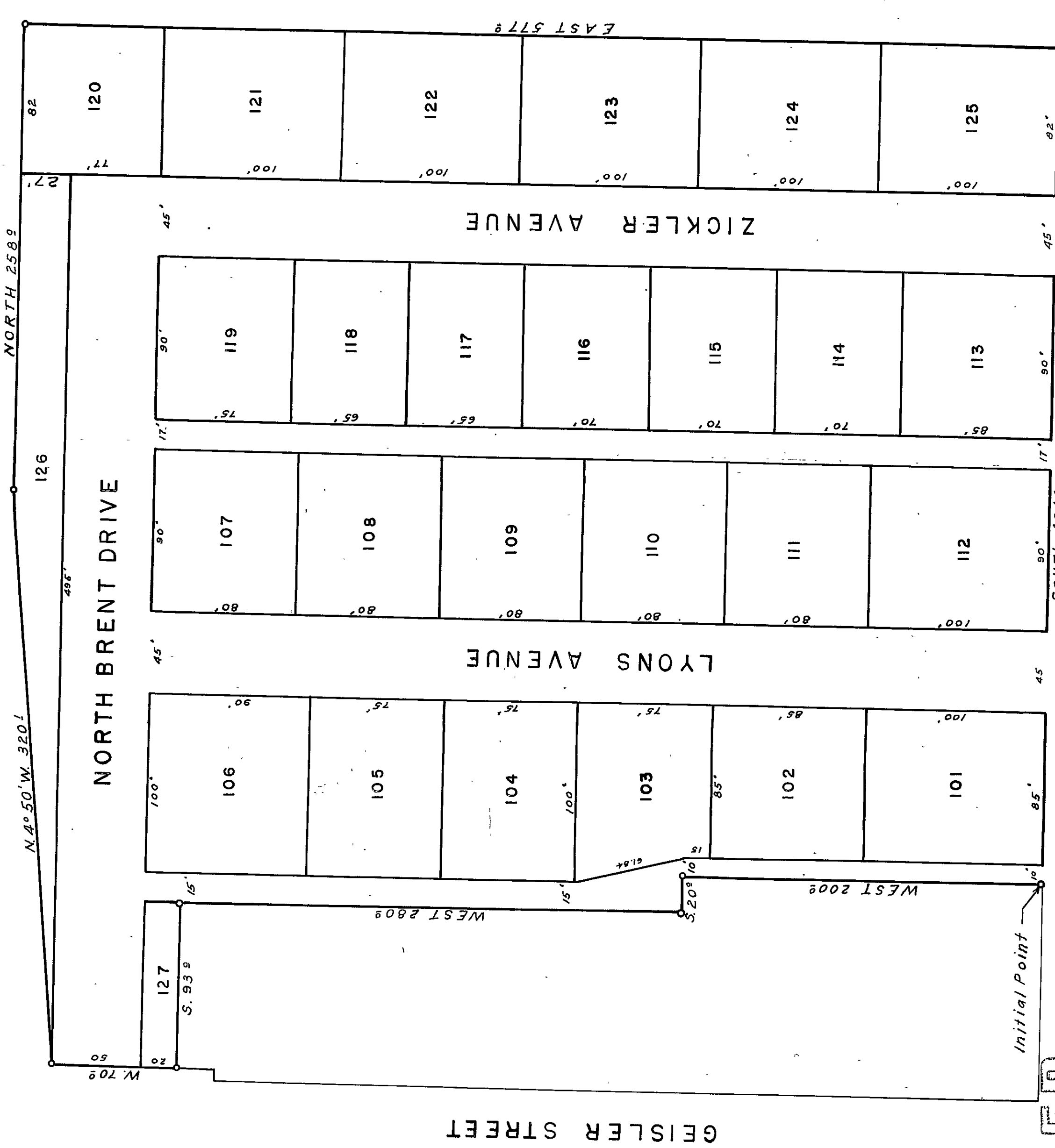
## APPROVAL
