Certificate of Surveyor

I, L. Lucas, first being duly sworn, depose and say that I made the survey of Breedlove Addition to John Day Oregon, as represented on this map, that the land included within boundaries as plotted is in the SW 1/4 of Section 23, Twp 13 S. R. 31 E. N.W. That this map correctly represents the ground as surveyed and described as follows: - Beginning at the initial point, a 2 inch iron pipe at the SW corner of Lot 80 of the Geister Addition, City of John Day, Grant County, Oregon. Which point is 32.40 feet North from the South East corner of the SW 1/4 of Said Section 23, Twp 13 S. R. 31 E. N.W. Thence East along the South line of the Geiser Addition a distance of 200.0' thence South a distance of 120.0 feet; thence East a distance of 40.0 feet to a point 125.0 feet West of the West side line of Bridge Street, thence South 123.5 East, parallel with said Bridge Street a distance of 101.8 feet. Thence West a distance of 255.5 feet; thence North a distance of 72.9 feet, to the Easterly boundary of Main Street, Section N. 210.55 E. along said Easterly boundary, a distance of 311 feet. Thence North along said boundary line, a distance of 120.0 feet to the point of beginning.


