


MAP OF GLOVER ADDITION

I, L. E. Lucas, do hereby certify that I made the Survey of the Glover Addition to Mt. Vernon, as represented on this map, that the land included within the boundaries as plotted is within the E $\frac{1}{2}$ 5 $\frac{1}{2}$ Sec 21 T 35 R 30 E W.M. That this map correctly represents the ground as surveyed and described as follows:
Beginning at the Initial Point, a $\frac{1}{2}$ iron Stake, which point is 697.9 feet North, and 3.25 feet West from the S $\frac{1}{2}$ cor Sec 21 T 35 R 30 E W.M. Thence N 89° 51' W, parallel to the Section Line 259.0, thence S 0° 16' E. 170.0, thence N 89° 51' W 65.0, thence N 0° 16' W 673.6, thence N 89° 44' E. 194.0, thence S 0° 16' E 55.0, thence N 89° 44' E. 125.0, thence S 0° 16' E. 450.9, to point of beginning.
