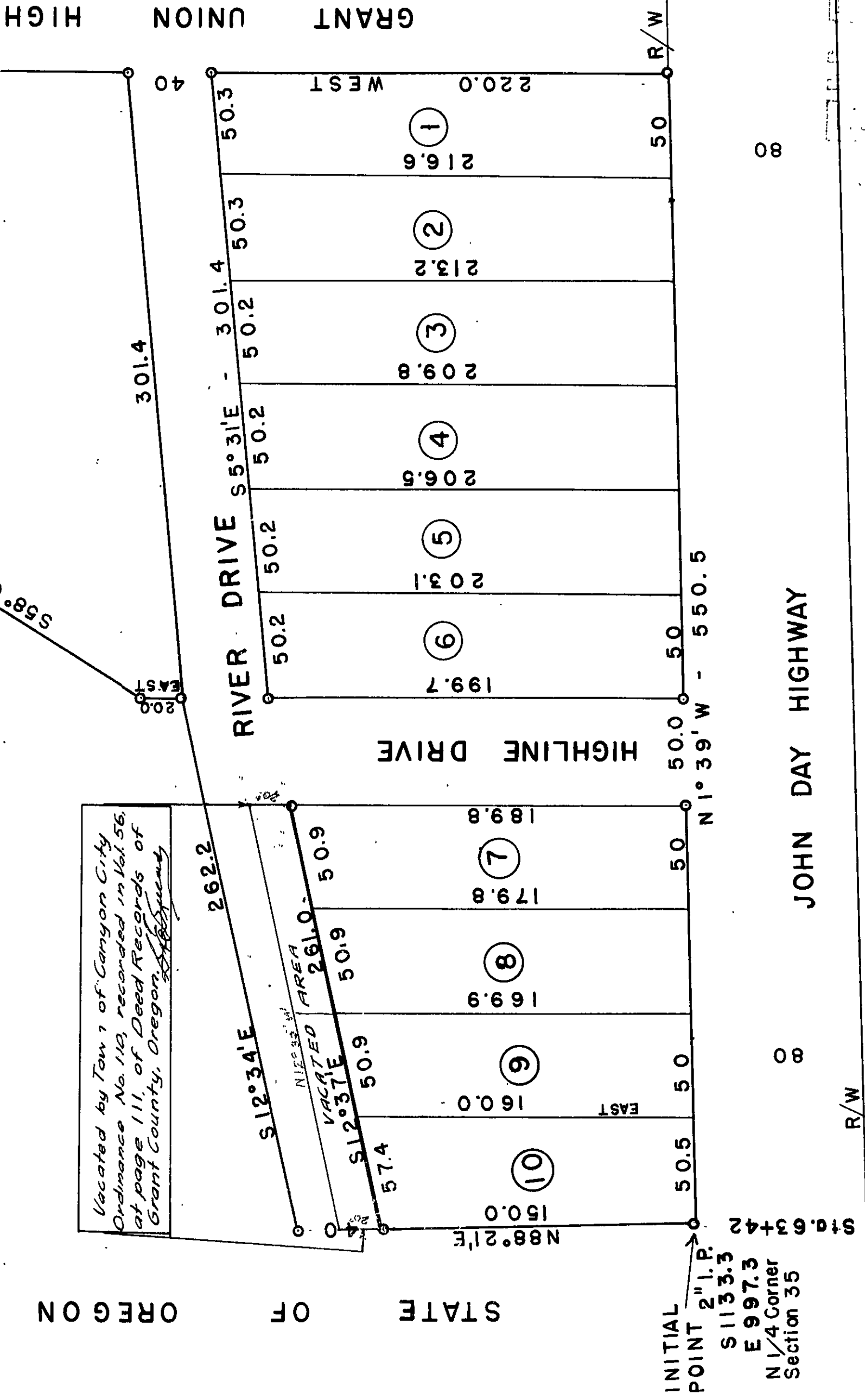


HIGHWAY ADDITION

CERTIFICATE

I, L. E. Lucas being first duly sworn depose and say that I made the Survey of Highway Addition represented on this map, that included within boundaries as plotted is within the NW 1/4 of Section 35, T13S, R31E, W1M. That this map correctly represents the grounds surveyed and described as follows:

Initial Point - 2" iron pipe driven in ground to within 6" of surface on west right-of-way line of the John Day Highway, said point being 1133.3 feet south and 997.3 east of the North Quarter Corner of Section 35. Boundaries - Starting at the initial point, Thence N1°39'W 550.5 ft, thence West, 480.0; thence S8°35'E, 120.0 ft, thence S23°47'E, 750.0 ft, thence S58°05'E, 213.0 ft, thence East, 20.0 ft, thence S12°34'E, 262.2 ft, thence N88°21'E, 190.0 ft.

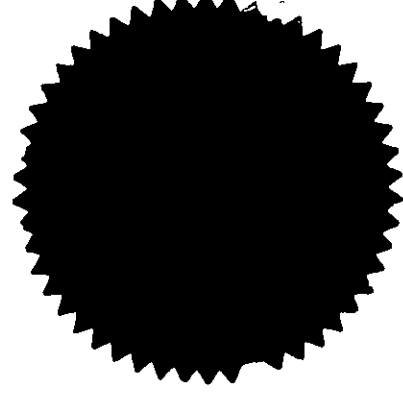
