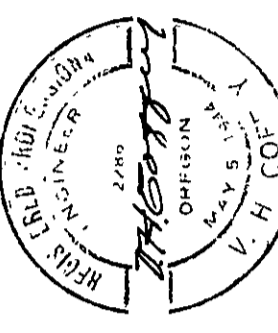


**CERTIFICATE**

I, V.H. Coffey being first-duly sworn depose and say that I made the survey of Masson Addition as represented on this map, that land included within boundaries as plotted is within the City Limits of Canyon City. That this map correctly represents the ground as surveyed and described as follows:—

 Boundaries:—Starting at initial point, thence S89°18'W, 142.5 ft; thence N13°02'W, 336.8 ft; thence N12°04'E, 244.0 ft; thence East, 264.6 ft; thence S16°11'W, 417.7 ft; thence S6°41'E, 165.0 ft.

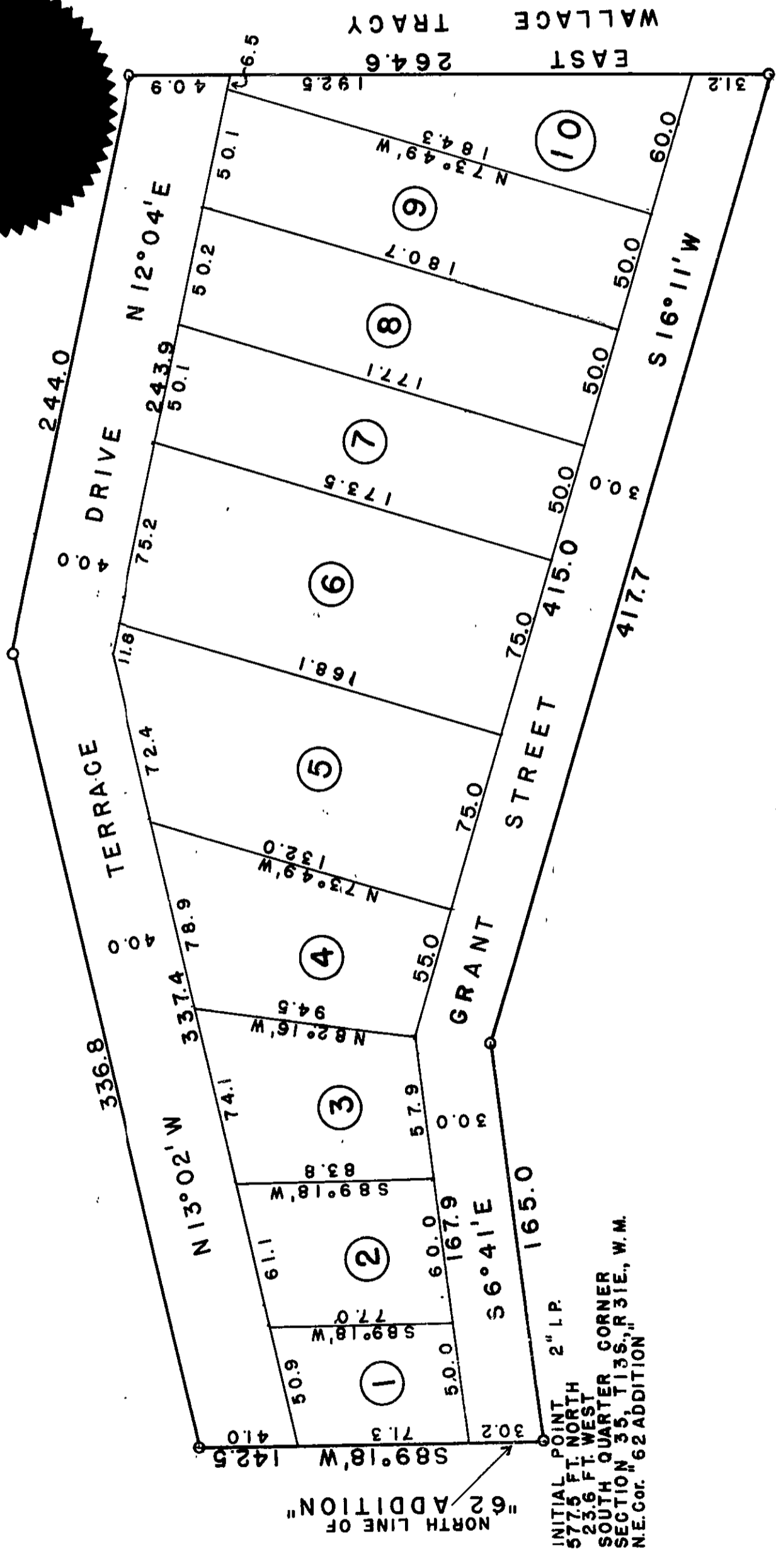
