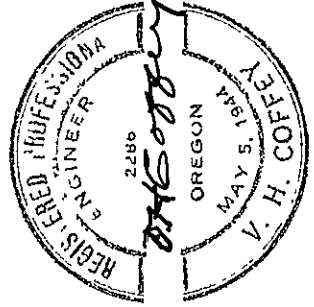


PROPHET ADDITION TO CANYON CITY - GRANT COUNTY - OREGON

I, V.H. Coffey, being first duly sworn depose and say that I made the survey of Prophet Addition to Canyon City as represented on this map. That land included within boundaries as platted is within the W 1/2 NE 1/4 and NW 1/4 SE 1/4 of Sec. 35 T. 13. S. R. 31. E. W. M. That this map correctly represents the ground as surveyed and described as follows:-
Beginning at the initial point, a 2-inch iron pipe driven in the ground at the S.E. corner of this tract, which point is 243.44 ft. N. and 467.1 ft. E. from the S. 1/4 corner of Sec. 35 T. 13. S. R. 31. E. W. M. Thence, N. 88° 30' W. 245.04 feet, S. 01° 22' W. 50.0 feet, N. 65° 55' W. 296.5 feet, N. 2° 08' E. 297.5 feet, N. 4° 00' E. 249.3 feet, N. 3° 59' W. 192.4 feet, N. 1° 09' W. 199.3 feet, N. 6° 10' W. 532.6 feet, N. 5° 00' E. 403.1 feet, N. 3° 00' E. 197.1 feet, North 330.8 feet, East 399.0 feet, S. 28° 02' E. 139.3 feet, S. 55° 09' E. 227.5 feet, S. 1° 16' W. 45.0 feet, S. 1° 39' E. 450.0 feet, S. 4° 29' W. 61.5 feet, S. 4° 51' W. 908.9 feet, S. 4° 00' W. 600.9 feet to point of beginning.
