


PROPHET ADDITION

That land included within boundaries as platted is within the NW $\frac{1}{4}$ NE $\frac{1}{4}$ and NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Sec. 35 T. 13. S. R. 31. E. W.M. That this map correctly represents the ground as surveyed and described as follows— Beginning at the initial point, a 2-inch iron pipe driven in the ground at the S.E. corner of this tract—which point is 243.74 ft. N. and 46.71 ft. E. from the S. 1/4 corner of Sec. 35 T. 13. S. R. 31. E. W.M. 
