

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: *
The corner was established by H. Gradon in 1881 under
Contract No. 383. The original notes state:

A pine 24 ins dia bears N74°W 32 lks dist
A pine 18 ins dia bears N35°E 150 lks dist
A pine 5 ins dia bears S40°E 110 lks dist
A pine 24 ins dia bears S75°W 47 lks dist.

Description of corner evidence found:

Found no evidence of the original post.
A burned pine stump bears S77°29'W 31.8 ft to face (S75°W 47 lks) face & chaining notch visible.
A burned pine stump bears N 74°06'E 21.8 ft to face (N84°W 32 lks) face & chaining notch visible.
A pine stump bears N37°04'E 98.9 ft (N35°E 150 lks) no marks.
An 18" Pine bears S42°41'E 72.8 ft (S40°E 110 lks) healed scar.

Description of monument and accessories I establish to perpetuate the original location of this corner:

Reestablish this corner from the four found original bearing trees. Set a 2-1/2" aluminum monument 22" in the ground in a mound of stone.

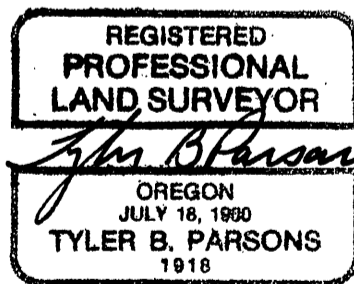

An 8" Pine bears N45°07'W 42.4 ft scribed T10SR32ES14BT.
A 13" Pine bears N46°30'E 20.9 ft scribed T10SR32ES13BT.
A 9" Pine bears S60°33'E 22.7 ft scribed T10SR32ES24BT.

New BTs have 3/4" brass washers marked PLS1918 attached to the BT blaze, faces and bands painted with red tree marking paint, and BT tags and Attention or Land Survey Monument signs. A steel fence post with Attention or Land Survey Monument sign is driven approximately 3-5 feet from the corner
