

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: *
The corner was established by H. Gradon in 1881 under
Contract No. 383. The original notes state:

from which
A pine 24 in dia bears N55°W 72 lks dist
A pine 18 in dia bears N65°E 27 lks dist
A pine 18 in dia bears S78°E 124 lks dist
A pine 40 in dia bears S49°W 81 lks dist.

Description of corner evidence found:

Found a 12x8x6 stone, 2 grooves & 1 groove on appropriate faces, N64°W
37 feet from the corner position determined from 4 original bearing trees.
A 14" pine stump bears N68°E 18.1 ft (N65°E 27 lks), no marks remaining.
An 18" pine stump bears S75°28'E 82.6 ft (S78°E 124 lks), S25BT & chaining
notch visible on detached fragment.
A 36" pine stump bears S47°34'W 54.8 ft (S49°W 81 lks), no marks remaining.
An 18" pine stump bears N52°15'W 48.4 ft (N55°W 72 lks), possible chaining
notch.

**Description of monument and accessories I establish to perpetuate the
original location of this corner:**

Reestablish this corner from the original bearing trees. Set a
2-1/2x30" aluminum monument 22" in the ground in a mound of stone
& buried the original on the north side.

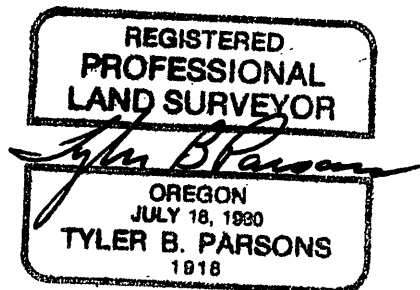
New BTs:

A 12" Fir bears N6°15'W 23.8 ft scribed T10SR32ES23BT.
A 9" Pine bears N48°E 37.7 ft scribed T10SR32ES24BT.
A 15" Fir bears S28°E 43.1 ft scribd T10SR32ES25BT.
A 12" Pine bears S44°58'W 17.3 ft scribed T10SR32ES26BT.

New BTs have 3/4" brass washers marked PLS1918 attached to the BT
blaze, faces and bands painted with red tree marking paint, and
BT tags and Attention or Land Survey Monument signs. A steel fence
post with Attention or Land Survey Monument sign is driven
approximately 3-5 feet from the corner.
