

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

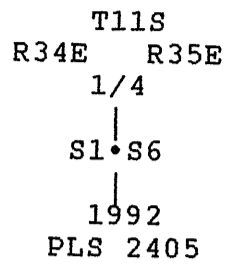
History of original corner establishment:

This corner was originally established by Bamford Robb and Herman D. Gradon, in 1881 under GLO Contract Number 383. Surveyor General Field Notes state:

Set a basalt stone 14x10x8 for 1/4 sec. cor. from which

A Pine 40 in. dia. bears N85°E, 85 lks. dist.
A Pine 40 in. dia. bears S80°W, 64 lks. dist.

Description of Corner Evidence Found:

Found a 14"x11"x8" stone in a small mound of stone. No marks visible on the stone.

Ponderosa Pine, 40" dia., stump with scribing visible, bears N84°23'E, 55.32 ft. (Rec: N85°E, 56.10 ft.)

Ponderosa Pine, 40" dia., stump with small portion of blaze face remaining, bears S84°42'W, 41.72 ft. (Rec: S80°W, 42.24 ft.)

Description of monument and accessories I established to perpetuate the original location of this corner:

Set 2-1/2"x30" aluminum pipe with 3-1/4" aluminum cap, stamped as shown on the DIAGRAM, 25" in the ground and buried the original stone on the north side of the monument.

From Which:

- Ponderosa Pine, 22" dia., bears N20°15'W, 23.6 ft., scribed: 1/4 S1 BT
- Ponderosa Pine, 14" dia., bears N17°45'E, 22.6 ft., scribed: 1/4 S6 BT
- Ponderosa Pine, 20" dia., bears S42°15'E, 9.3 ft., scribed: 1/4 S6 BT
- Ponderosa Pine, 24" dia., bears S52°30'W, 29.3 ft., scribed: 1/4 S1 BT

Measurements to BT's taken with a magnetic compass, declination 20° East, and a nylon clad steel tape. Set steel fence post with Land Survey Monument (54-9) sign 5' north of the monument. Nailed a brass washer stamped PLS 2405 on blaze above BT scribe as taken this survey. Nailed Bearing Tree (54-3) signs above blaze and Land Survey Monument (54-9) signs on back of each tree as required. Painted a 6" red band above Bearing Trees signs and painted blaze red.
