

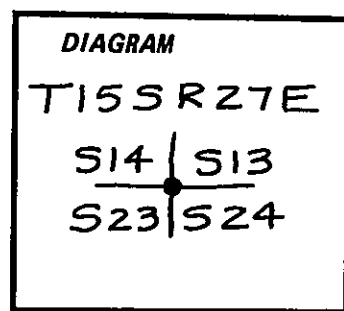
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner established by Samuel W. Lackland, Deputy Surveyor, under G.L.O. Contract No. 384 dated March 29, 1881.

Surveyor General's records state:

North between Secs 23 & 24 VA 19° E  
80.00 Set basalt stone 16X16X4 in mound of stone for Cor to Secs. 13, 14, 23 & 24 from which a Pine 28 in. dia. bears S36°E 62 Lks. dist. A Fir 14 in. dia. bears N28°W 91 Lks. dist.

Description of corner evidence found:

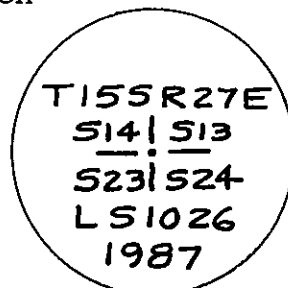
At assumed corner location found basalt stone 15"X10"X5" with 3 notches SW edge and 1 notch SE edge with "+" on top set upright on West side of 2-1/2 foot diam. stone mound consisting of approx. 5 other stones, large end of stone set down. Found original NW BT, a 30" Douglas Fir snag, which I opened to reveal scribing "R 1" bears North 33° West, 61.35ft. (60.8 ft. to face); found original SE BT, a 42" Ponderosa Pine with healed face bears South 30° East, 42.4 ft. to center.

Description of monument and accessories established to perpetuate the original location of this corner:

At position of original stone in stone mound, set 2-1/2 inch O.D. X 30 inches long aluminum pipe 15 inches in ground to bedrock with 3 inch cap marked as shown:

Marked bearing trees:

- A 7" Ponderosa Pine bears North 3-1/2° East, 13.5 ft., scribed-T15SR27ES13BT;
- A 10" Douglas Fir bears South 31-1/2° West, 13.2 ft., scribed-T15SR27ES23BT;
- A 13" Ponderosa Pine bears North 54° West, 95.1 ft., scribed-T15SR27ES14BT.



M.V.19-1/2°E.

Deposited original stone East of pipe and raised stone mound 3 foot diam. to cap. Set steel post 5 feet North with sign 54-4 facing cap. Painted red band and faces red and nailed signs 54-3 and 54-4 to BT's. Nailed brass washer stamped "AS&E LS1026" to faces of new BT's.

I hereby certify that the above corner monument was re-established as herein described on May 19, 1987.
