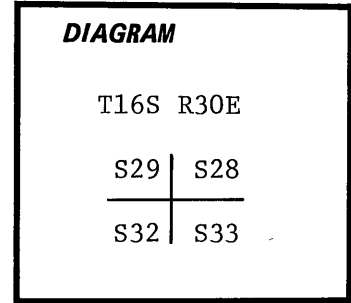


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner established in 1880 by S. W. Lackland under General Land Office Contract No. 357
 Surveyor General Record states:
 Set post for corner to sections 28, 29, 32 & 33
 From which:
 A pine 42 ins. diam. bears N. 65° E., 67 lks.
 A pine 30 ins. diam. bears S. 60° E., 92 lks.
 A pine 24 ins. diam. bears S. 85° W., 6 lks.
 A pine 30 ins. diam. bears N. 82° W., 32 lks.



Description of corner evidence found:

FOUND ORIGINAL BT's From the corner position:

A pine stump 36 ins. diam. bears N. 53° E., 44.5 feet blazed not marked
 A pine stump 18 ins. diam. bears S. 68° E., 61.5 feet marked "BT"
 A pine 34" diam. bears S. 50° W., 4.0 feet marked T16SR30E BT
 A pine 32" diam. bears N. 33° W., 21.1 feet scribing is burnt out.
 Measured to face of blazes.
 No evidence of original post was found.

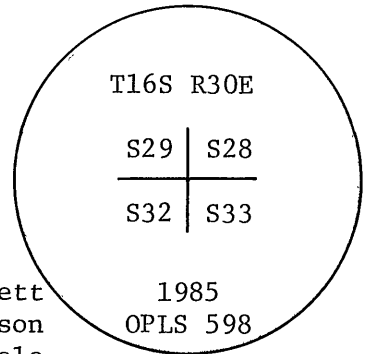
Description of monument and accessories established to perpetuate the

original location of this corner: At a point that best fits the record distances from the four original BT's I set a 2½"x30" aluminum pipe with an aluminum cap buried 25 inches in the ground. Marked cap as shown,
 From which:

I scribe new BT's

A pine 14" diam. bears N. 61° E., 36.5 feet marked T16SR30ES28BT
 A pine 11" diam. bears S. 74° E., 76.0 feet marked T16SR30ES33BT

Nailed brass washer marked OPLS 598 to lower blaze of new BT's. Painted 6" red band around new BT's above blaze and attached BT sign and attention sign to BT's. Set steel fence post approx. 5 feet South from monument and attached appropriate signs as called for in my contract. Used magnetic compass with 20° E. var. and steel tape measuring to a 40d nail driven in side center at root crown of new BT's.
