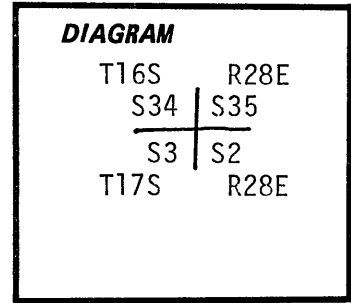


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

**History of original corner establishment:**

GLO, 1880, by Banford Robb, contract #366.  
 Set 30"X16"X8" Basalt stone in mound of stone.  
 60" Pine N15°E 40 links (26.4').  
 12" Pine S30°E 78 links (51.5').

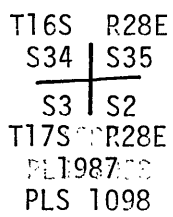


**Description of corner evidence found:**

28"X16"X10" Basalt stone in mound of stone with 4 notches on west and 2 notches on east.  
 38"X40" high Ponderosa pine stump N15°E 26.2' to face, "BT" visible on lower face, upper face with scribe marks visible on felled portion of tree, lying southerly from stump.  
 20"X18" high Ponderosa pine stump (badly rotted) S23°E 48.1' to face, "BT" visible on lower face, upper face missing.

**Description of monument and accessories I established to perpetuate the**

**original location of this corner:** Set 2 1/2"X30" alum. pipe with 3" alum. cap marked: 24" in ground in place of original stone, with mound of stone to cap.  
 Buried original stone in south portion of mound.  
 11" Juniper S57 1/2°W 57.9', scribed "T17SR28ES3BT".  
 10" Juniper N21°W 11.0', scribed "T16SR28ES34BT".  
 10" Juniper N13 1/2°E 21.5', scribed "T16SR28ES35BT".  
 12" Juniper S54°E 12.1', scribed "T17SR28ES2BT".  
 Set 6' metal fence post 1.5' South with USFS 54-4 sign.  
 Corner is on a gentle south slope.  
 BT's have USFS 54-3 and 54-4 signs. New BT's have a 60d nail with a 1 1/2" alum. disk marked "C. WAYNE COOK PLS 1098" in side center at base. Distance measured to nail with steel tape. Bearings measured with a Silva Ranger compass (Var. 19° east).
