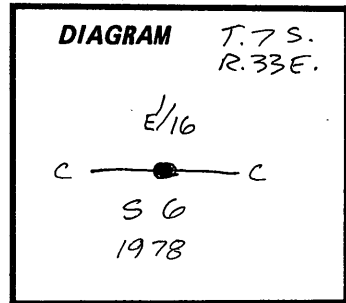

A PINE, 18" DIAM., BEARS N. 37° 17' E., 17.77 FT., (RECORD N. 43° E., 17.7 FT.) HEALED BLAZE, U.S. FOREST SERVICE SIGNS 54-9 AND 54-3 ATTACHED.

PAINTED 6" RED BAND AROUND EXISTING TREE

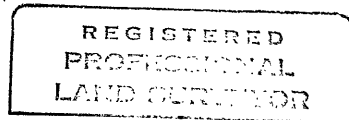

PAINTED STUMP OF FALLEN BT AND ATTACHED 54-9 USFS SIGN.

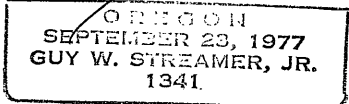
MAGNETIC DECLINATION USED AT THIS CORNER TO ESTABLISH BEARINGS: DC; 19° E.
