

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner established by Herman D. Gradon, under contract No. 499 dated March, 1884.

The original notes state that at the corner:

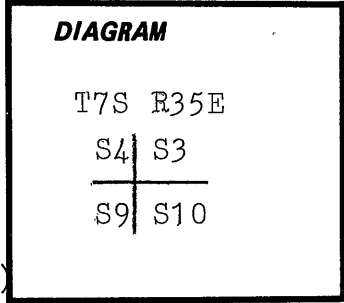
A 4 in. square by 4 ft. marked post set 24 in. in the ground for the corner, from which:

A 8 in. dia. Tamarack bears N30°E - 13 lks (8.6 ft.) marked: T7S R35E S3 BT

A 8 in. dia. Tamarack bears S17°E - 4 lks (2.6 ft.) marked: T7S R35E S10 BT

A 6 in. dia. Pine bears S38°W - 30 lks (19.8 ft.) marked: T7S R35E S9 BT

A 6 in dia. Pine bears N11°W - 16 lks (10.6 ft.) marked: T7S R35E S4 BT



Description of corner evidence found:

A 17½ in. dia. Tamarack bears N30°E - 13 lks (8.6 ft.) with visible scribing.

A 17 in. dia. Tamarack bears S17°E - 4 lks (2.6 ft.) with healed blaze.

A 8½ in. dia. Pine snag bears S40°W - 30 lks (19.8 ft.) with scribing visible.

Corner was re-established by distance-distance intersection from the found bearing trees.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set: A 2½ in. X 30 in. aluminum pipe, with a 2½ in. aluminum cap, 18 in. in the ground with a mound of earth to the cap, from which:

A 16 in. dia. Tamarack bears S39°W - 22.2 ft., scribed: T7S R35E S9 BT

A 5½ in. dia. Fir bears N66°W - 24.8 ft., scribed: T7S R35E S4 BT

Each new bearing tree has a brass washer stamped PLS 1106 nailed to the face of the blaze. Attached signs 54-3 and 54-4 and painted the face of the blaze and a 6 in. red band around each bearing tree.

Set a steel fence post, with 54-4 sign attached, South of the monument.

Used a steel tape and a magnetic staff compass, with 20° East declination. Measured to the center of the bearing trees.

This corner was monumented on September 6, 1983.

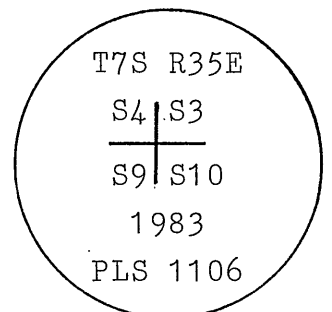
