

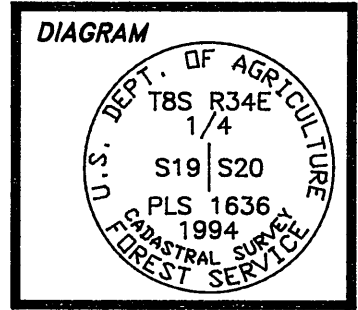
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

1884, HERMAN D. GRADON, UNDER CONTRACT NO. 499, ESTABLISHED THE CORNER. HE SET A POST 3' LONG & 3" SQUARE, 24" IN THE GROUND, FROM WHICH:
15" FIR, S. 50° E., 42 LINKS.
14" FIR, S. 5° W., 18 LINKS.

1994, DENNIS L. GAYLORD, PLS 1636, FOUND THE BTS AND SET AT RECORD BEARING AND DISTANCE A 2 1/2" BY 30" ALUMINUM PIPE, WITH 3 1/4" ALUMINUM CAP, 24" IN THE GROUND AND SURROUNDED BY A STONE MOUND, FROM WHICH:
22" DOUGLAS FIR, S. 5° W., 11.88 FEET, WITH HEALED SINGLE BLAZE.
ROOT CROWN OF ORIGINAL 15" FIR, S. 50° E., 27.72 FEET, THERE IS NOTHING LEFT OF THE TREE OTHER THAN THE ROOT CROWN.
MARKED NEW BT'S:
18" WESTERN LARCH, S. 83°45' E., 47.6 FEET.
9" LODGEPOLE PINE, N. 28° E., 28.8 FEET.
9" LODGEPOLE PINE, N. 42° W., 46.4 FEET.

FOUND A 2 1/2" ALUMINUM PIPE, WITH 3 1/4" ALUMINUM CAP, PROJECTING 6" OUT OF THE GROUND AND SURROUNDED BY A STONE MOUND, MARKED AS SHOWN (SEE DIAGRAM), FROM WHICH:

9" LODGEPOLE PINE, N. 28° E., 28.8 FEET, SCRIBING "1/4 S20" BT" VISIBLE ON DOUBLE BLAZE (1994 BT).
18" WESTERN LARCH, S. 83 3/4° E., 47.6 FEET, SCRIBING "1/4 S20" BT" VISIBLE ON DOUBLE BLAZE (1994 BT).
22" DOUGLAS FIR, S. 5° W., 11.9 FEET, WITH A HEALED BLAZE (ORIGINAL BT).
9" LODGEPOLE PINE, N. 42° W., 46.4 FEET, SCRIBING "1/4 S19" BT" VISIBLE ON DOUBLE BLAZE (1994 BT).

THE 1994 BT'S HAVE A 3/4" BRASS WASHER STAMPED "PLS 1636" NAILED TO THE SCRIBED "B" ON THE LOWER BLAZE.
