

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner established by Herman D. Gradon, GLO Contract No. 499, dated March 11, 1884. Record states:

Set a post 3 ft. long 3 ins. sq. 24 ins. in ground for 1/4 sec. cor. marked 1/4 S. on W. face; from which A pine 7 ins. dia. brs. N. 21° E. 20 lks. dist. marked 1/4 S.B.T.

A pine 13 ins. dia. brs. S. 86° W. 25 lks. dist. marked 1/4 S.B.T.

Corner perpetuated by Duane I Griffith, PLS 644, Grant County Survey No. 1019, dated 1987. Record

States: No evidence of the original corner or its accessories were found. At position determined by survey, I set a 2 1/2" x 30" aluminum pipe with aluminum cap marked as shown (see corner diagram), 29 inches in the ground, from which: New Bearing Trees:

A 11 inch diameter Ponderosa Pine bears S22°E, 22.13 feet marked 1/4 S25

Description of corner evidence found:

A 2 1/2" aluminum cap on a 2 1/2" aluminum pipe in a surrounding mound of stone, fence post alongside with sign 54-9 attached.

1987 Bearing Trees:

A 12" diameter ponderosa pine bears S 22° E, 22.13 feet with fully healed double blaze.

A 24" diameter ponderosa pine bears N 66° W, 28.96 feet with visible scribes on partially healed double blaze.

Description of monument and accessories I established to perpetuate the original location of this corner:

Nailed a 54-9 sign to each of the found bearing trees and painted blazes and a 6" band red.

New Bearing Trees:

An 8" diameter ponderosa pine bears S 81 3/4° E, 71.3 feet marked "1/4S25BT" on double blaze.

A 13" diameter ponderosa pine bears S 44 1/2° W, 33.1 feet marked "1/4S26BT" on double blaze.

Bearing trees have signs 54-3 and 54-9 attached below a 6" band of red paint. Each blaze painted red with a brass washer stamped "PLS 1106" attached to each new bearing tree.

Compass declination 18° East.
