

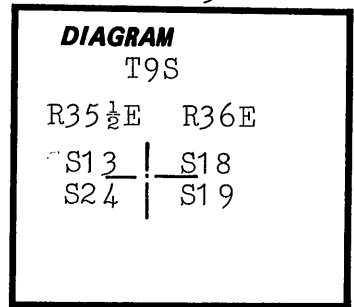
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

N-25

History of original corner establishment:

This corner was originally established by Eugene P. McCornack, U.S. Deputy Surveyor, under Contract No. 398 dated July 2, 1881. The original notes state that at the corner a 4' long by 4" square wood post was set 24" in the ground from which:

- A 10" pine bears N70°E-55 lks, marked T9S R36E S18 BT.
- A 7" pine bears S50°E-21 lks, marked T9S R36E S19 BT.
- A 8" pine bears S55°W-16 lks, marked T9S R35½E S24 BT.
- A 10" pine bears N30°W-20 lks, marked T9S R35½E S13 BT.



Description of corner evidence found:

Mound of stone with rotted remains of post in a hole in the middle of stone mound from which:

- A 12" lodgepole pine stump bears N70°E-36.3' with axe marks visible.
- A down, rotten, lodgepole pine bears S50°E-13.9'+ with visible scribing.
- A down, rotten lodgepole pine bears S55°W-10.6'+ with visible scribing.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a 2½" by 30" aluminum pipe with 2½" aluminum cap 26" in the ground and surrounded with a mound of earth and stone from which:

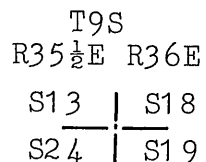
- A 18" douglas fir bears N11½°E-39.6' scribed T9S R36E S18 BT.
 - A 10" white fir bears S76½°E-39.8' scribed T9S R36E S19 BT.
 - A 10" douglas fir bears S42½°W-8.5' scribed T9S R35½E S24 BT.
 - A 11" douglas fir bears N17½°W-18.7' scribed T9S R35½E S13 BT.
- New bearing trees have a brass washer stamped PLS 1106 nailed to the face of blaze. Attached sign 54-3 and 54-9 and painted face of blaze and a 6" red band around each bearing tree. Set steel fence post North of corner and attached sign 54-9.

Used steel tape and staff compass with 20°E declination, measured to the center of the bearing trees.

This corner was remonumented on October 4, 1985.
